DECEMBER REC SUMMARY

The Revenue Estimating Conference (REC) met and revised its estimate for FY 2025 net General Fund Receipts (including transfers) on Dec.12. They agreed to decrease the estimate by \$85.3 million compared to the estimates they made in October. PERUSE THE MOST RECENT POLICY PRIMER

NOW AVAILABLE! The second quarter *Policy Primer* released on December 17 clarifies and cleans up policy language to enhance legal compliance for districts. In the Fall, the Iowa Department of Education clarified that the exemptions listed within the definition of truancy also apply to chronic absenteeism. The Department clarified that the exemptions listed within the definition of truancy also apply to chronic absenteeism. This clarification is now reflected in policy. Additional language updates better align with legislation on limitations to employment references, and districts' participation in the school food program.
